**Safety**

I am responsible for my own SAFETY. I must adhere to the Club's safety recommendations in wearing appropriate shoes, sliders, grippers etc. before entering the ice area. No street shoes are allowed. Helmets are strongly recommended. We will follow local public health recommendations throughout the curling season and thus masks, socially distancing, and cleaning brooms and sticks may be required.

**On Ice Accidents**

**All on ice accidents are to be reported immediately to the Tam Office staff.** They will handle 911 calls if necessary, administer use of defibrillator if required, and if necessary call the member's emergency contact.

**Privacy Clause**

All personal Information collected from you, including your email address, will only be used to reach you to discuss the status of your membership with the Club, Club roster, Bonspiel rosters (for communication ) and/or by the group in which you participate.

**Fee Rebate Policy**

Refund of fees is governed by our "Policy for refunds of Membership Dues". It is not the intent of The Board of Directors to withhold any legitimate rebate of curling fees. Any Venerables Member wishing to participate in an Ontario Curling Association (OCA) sponsored event must become an OCA member. OCA membership applications are available in the Tam Heather office. There is a fee.

**Curling Time Slots and Curling Season Schedule**

Refer to the annual Curling Calendar on the Venerables Website ([www.tamheathervenerables.com](http://www.tamheathervenerables.com)). The Board may adjust timeslots to accommodate Venerable events such as VTEC, SEMUT, internal or invitational bonspiels, and/or to maximize use of ice. Announcements for upcoming events will be made at Tag draw times, posted on the Venerables bulletin board and circulated in the "WEEK AHEAD" email.

**Visiting Guest Curler or Prospective New Curler Applicant**

A visiting curler or prospective New Venerable applicant is **not** permitted to curl unless (1) the 'Venerables Guest Curler Waiver form, (2) the Release of Liability Waiver form, (3) the Declaration of Compliance COVID-19 form and (4) a copy of verified proof of full vaccination receipt, have been completed/submitted and signed by the guest or New Venerable applicant. See your Board Captain or go the Tam Heather Venerables Website to obtain the forms for your quest to sign. A guest prospect may curl up to three (3) times without a payment of fee.

**Curling Clinic**

It is recommended that any Venerables Member with limited curling experience attend the Tam Heather Curling Clinic hosted by The Tam Heather Curling and Tennis Club.
